## **-Executive Summary-**

### **History**

A Woman's Heart Pregnancy Resource Center officially opened its doors on August 1, 2000 sponsored by Highland Terrace Baptist Church as a commitment and concern for the women in crisis pregnancy, to offer them life affirming choices. In September of 2002, A Woman's Heart became an independent 501(c)3 under the leadership of inter-denominational executive board to bring our community together in the commitment to serve these women. In November 2005, A Woman's Heart became a limited services medical clinic. This will enable us to provide pregnancy testing, first trimester ultrasound, and sexually transmitted disease testing in the future.

Under the leadership of the board, A Woman's Heart Pregnancy Resource Clinic provides a place where individuals in a crisis pregnancy find compassion and help without judgment or condemnation. If the woman rejects the life affirming choices offered and chooses to terminate her pregnancy, or has experienced a past abortion, counselors at the clinic are committed to offer the emotional support and personal concern a client can frequently find nowhere else. If the woman makes the choice to carry her pregnancy to term, the counselors offer long-term emotional support and education. Faced with what is likely the most agonizing decision of their lives, women often feel frightened, confused and alone. We are in the ministry of saving and rebuilding shattered lives.

### **Mission Statement**

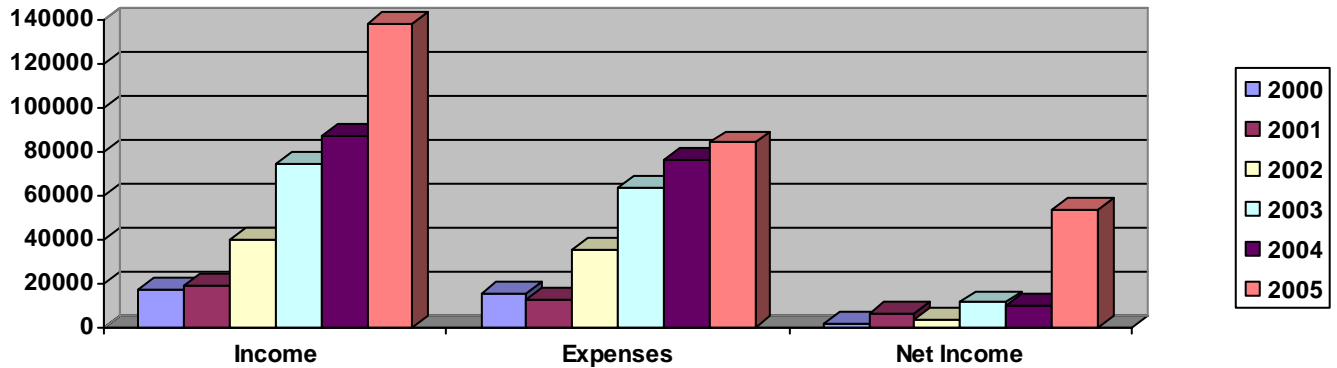

# CENTER GROWTH

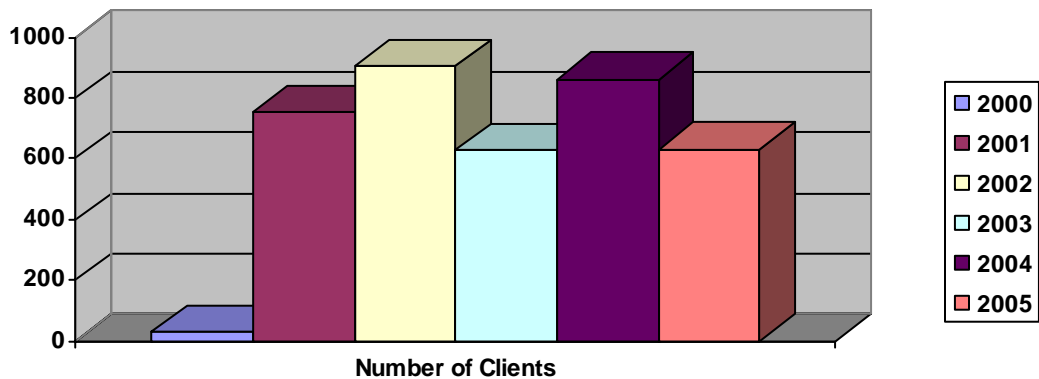
## -Income Growth-

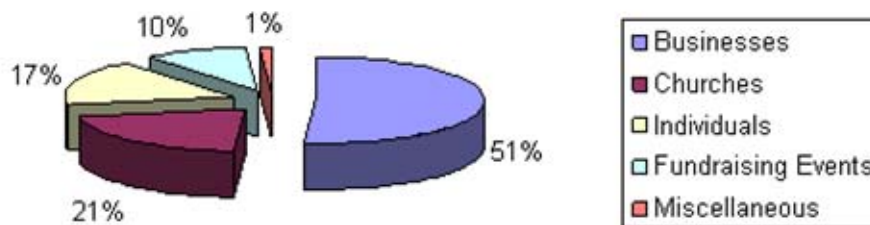

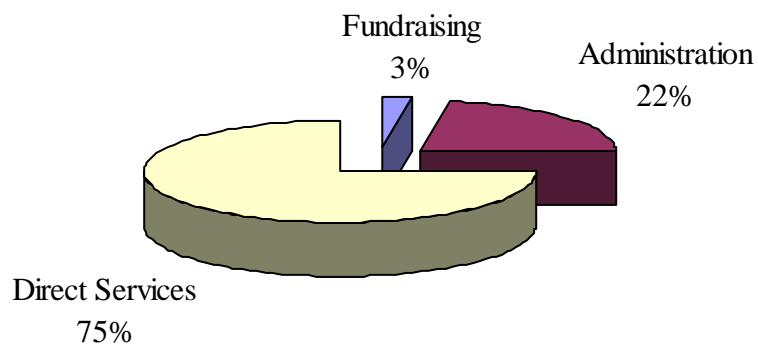
## -Source of Income-

## -Distribution of Funds-

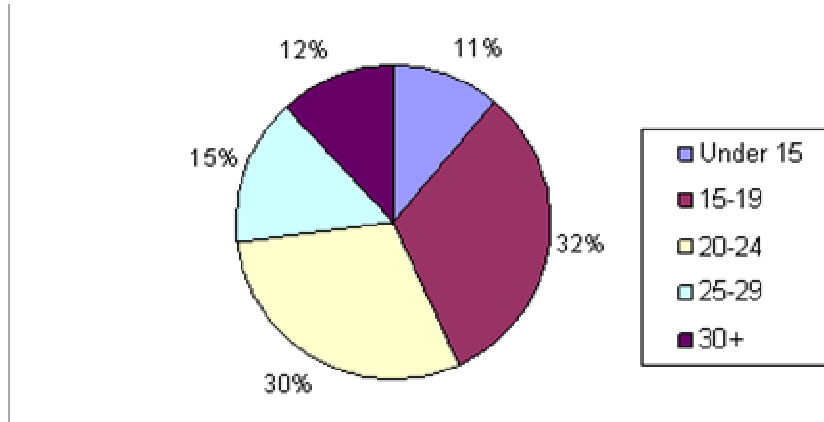
See the graph below for the percentage of expenditures for A Woman's Heart PRC.



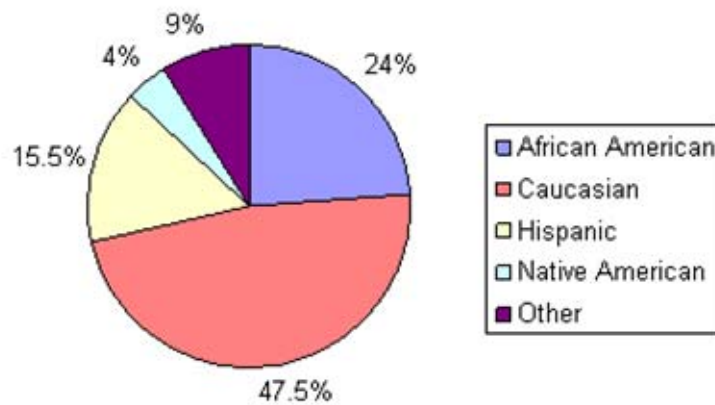

The graphs below illustrate the demographics of our clients seen during 2005.

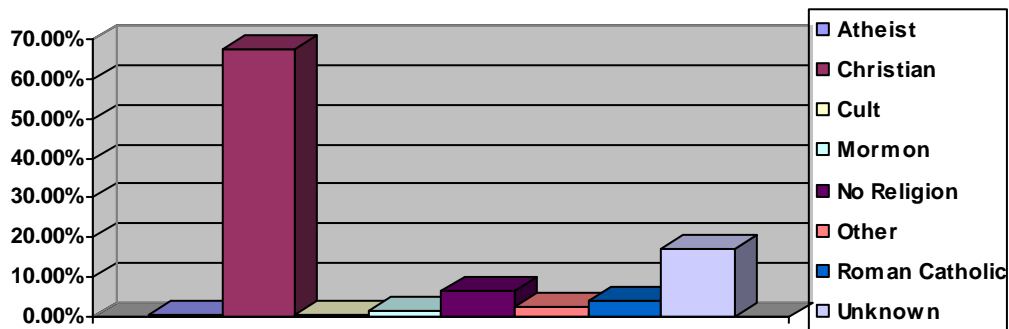
## -Ages of Clients-



## -Ethnic Origin-

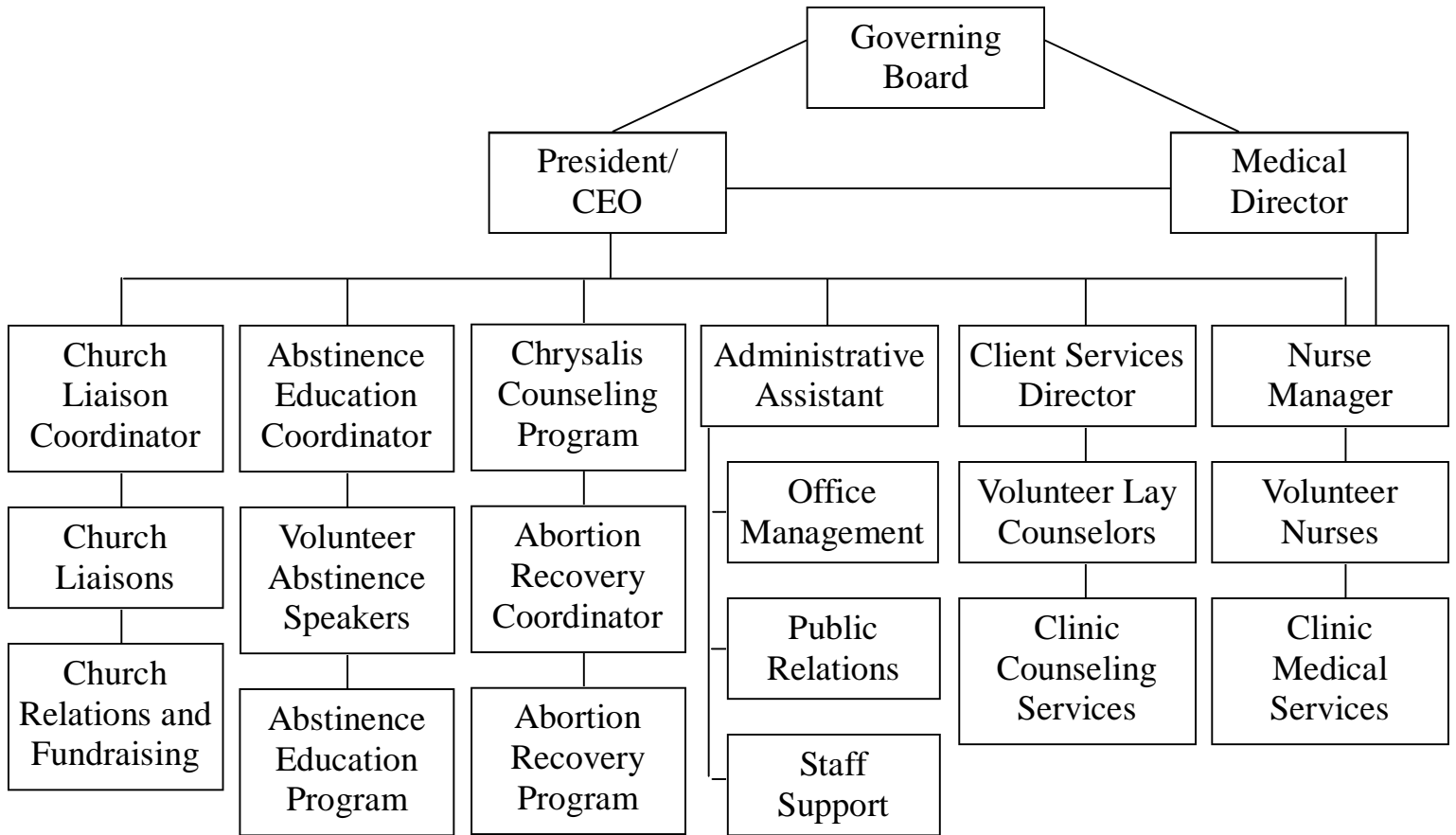


## -Religious Background-

# KEY PERSONNEL

---

## **-President/CEO-**

Responsible for implementing the mandates of the board, creating programs and services, determining costs of those programs and services, developing promotional and marketing campaigns and training and hiring the staff to meet the clinic's needs.

## **-Medical Director-**

Responsible for overseeing medical services provided at the Pregnancy Clinic.

## **-Nurse Manager-**

Responsible for overseeing medical staff, medical services, records and maintaining quality control.

## **-Client Services Director -**

Responsible for overseeing non-medical volunteer staff, volunteer scheduling, keeping programs and services flowing by making sure all the lay counselors have items needed to do their job.

## **-Administrative Assistant-**

Assist the CEO with writing, developing, and publishing all materials distributed by the Pregnancy Clinic and assist with bookkeeping, maintaining advertising, the website, and planning events.

## **-Abstinence Education Coordinator-**

Responsible for overseeing volunteer abstinence speakers and coordinating and maintaining the abstinence program.

## **-Church Liaison Coordinator-**

Responsible for overseeing volunteer church liaisons and assisting in church relations and fundraising.

## **-Abortion Recovery Coordinator-**

Responsible for overseeing and maintaining the abortion recovery program.

# CLIENT TESTIMONY

---

## -Barbara's Story-

Are you keeping the pain of your abortion hidden because you are afraid others will judge you or you are fearful you will lose your family, friends, and church? Abortion is murder, and it is normal to feel guilty, but Christ gave his life so that you might be saved. A Woman's Heart provides a way for you to find your way back to Him. Your pain, shame, or denial is what keeps you from having the relationship God wants to have with you. Please, believe me when I tell you God doesn't want you to hurt anymore.

I was like you; fearful and ashamed. I just could not allow myself to believe God still loved me- a murderer three times over. Childless for life because of the lies I believed. 'Just zygote cells'; not *a baby with a beating heart*.

I was 16 when the first two occurred and until receiving post-abortion counseling believed they were my guilt to carry alone. I know now these abortions were not my choice, not then anyway. Satan, the great deceiver, convinced me, you and so many others that it was our right to choose and not a child. I wasted 33 years carrying an adult's guilt and an abortionist's lie. 'It's just cells, like dead skin scraped off you finger tip'; not *an eternal soul in human form with perfect feet*.

Until I started the process of recovery with one-on-one help from a woman at A Woman's Heart, I had even denied the third pregnancy had occurred. Working through the process, I remembered 23 years after the fact that I had indeed chosen to let my third baby die in pain.

With a structured prayer and a repentant heart, I let go of these terrible lies and my sin. I will continue to grieve the loss of my children. I know they are in Heaven, and I long for the day I will see them. But, I no longer wish to hasten the day by destructive behavior or thoughts of suicide.

If you can relate to my story, call A Woman's Heart. Don't let Satan make you carry false guilt and continue to suffer in silence and shame for decades like I did. If you are considering abortion as a solution, please take a few minutes to read my story again.

I thank God for leading me to A Woman's Heart and the compassionate Christians who created a way for me to come home to the Lord. I am closer to being the woman He created me to be in this life.
