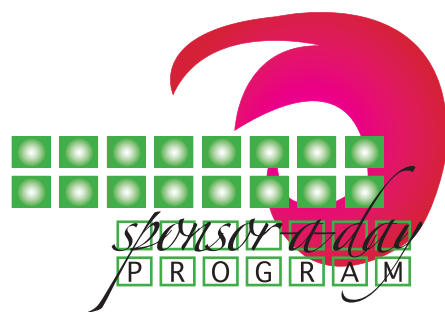


BENEFITS OF THE PROGRAM

The Sponsor-a-Day Program makes gift-giving easier for supporters of A Woman's Heart. The program is designed to be beneficial to both the clinic and donors.

A set giving plan and automatic transfers give donors the ability to dedicate funds to clinic while spending no time worrying about writing checks or forgetting to send monthly or annual donations.

It provides the clinic with a more stable budget, increased foresight into the future growth and improvement of the clinic, and greater security in knowing that all expenses will be covered so that efforts can be focused on the center instead of fundraising.



TERMS AND CONDITIONS

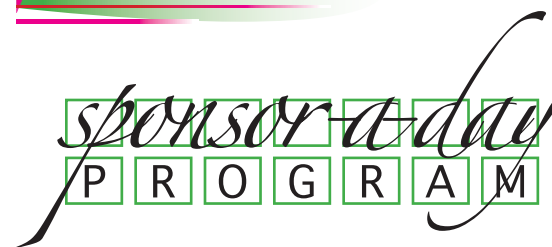
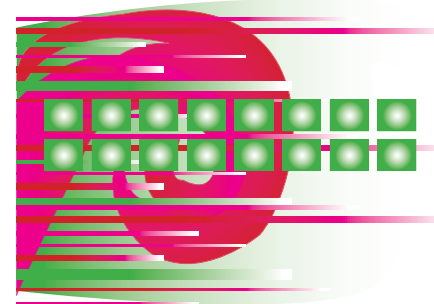
The authorization to charge your bank account or credit card is the same as if you had personally signed a check to A Woman's Heart. This agreement will remain in effect until you write a letter to us requesting that we end this agreement, providing us with a reasonable amount of time to act on it.

A record of your gifts will be included on your bank or credit card statement. If there is an error, you are responsible for notifying A Woman's Heart. We will correct it as soon as possible. Also, if there is an error, you have the right to tell your bank to reverse any transfer. This must be done in writing to your bank within 15 days of the date on the bank statement or within 45 days after the transfer was made.

The bank or credit institution is not responsible for an error in the amount of your transferred gift. If there is an error, please handle it directly with A Woman's Heart.

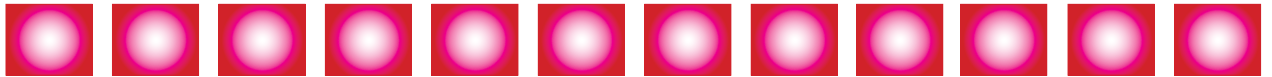
ABOUT THE PROGRAM

The Sponsor-a-Day Program provides donors with the opportunity to financially support all of the clinic's activities for one day or more each year.

Donors will choose which day or days they would like to sponsor and pay an annual donation of \$240 or divide the donation into 12 monthly payments of \$20 for each day sponsored.

This is the approximate daily cost of operation for A Woman's Heart based on the clinic's budget, and it includes all of the clinic's bills, supplies, medical expenses, and staff costs.

Donors may want to choose to sponsor a day that has special meaning to them, such as birthdays or anniversaries, or they may want to sponsor in memory of a loved one.



HOW IT WORKS

The Sponsor-a-Day Program operates through the Simple Giving Plan, which allows for all monies given to A Woman's Heart to be automatically transferred from the donor's account or card to A Woman's Heart. Once the donor chooses whether to give annually or monthly, automatic transfers are set up to be either

1. automatically deducted from the donor's checking or savings account through electronic funds transfer

or

2. automatically charged to the donor's Visa or MasterCard.

Once the donor fills out a Sponsor-a-Day commitment form, the transfer or monthly transfers will occur automatically.

If at any time the donor wishes to change the gift amount or discontinue using the Sponsor-a-Day program, they should contact A Woman's Heart.

All transfers are secure and if there are any problems, the donor should consult the Terms and Conditions of the Sponsor-a-Day Program for instructions.

SPONSOR REPORTS

At the end of the donor's sponsored day, a report will be sent accounting all of the activities of the clinic on that day. If the sponsored day falls on a weekend or holiday, the next business day will be reported.

The report will include the number of clients seen, testimonies of the clients seen, number of clients lead to Christ, number of women who chose life for their child, and any other important activities that occur throughout the day.

At the close of the year, all donors will receive a receipt of all gifts given for their tax records.
